

# TEAMS AUTOMATICALLY RECLASSIFIED BY THE USSSA BY-LAWS FOR 2015

(Updated August 17, 2015)

***PLEASE NOTE:** Teams required to compete at a higher classification in 2015 by the USSSA By-Laws that may be inadvertently omitted from the list below are not exempt from being reclassified. All tournament results are rounded up. Teams that do not participate in the tournament, and teams that are playing up in class (e. g. a D team participating in the C State Tournament), are not included when tabulating the size of a tournament for the purpose of reclassifying teams).*

## **AUTOMATIC MOVE UP OF 2014 USSSA MEN'S CLASS "B" TEAMS:**

The USSSA Slow Pitch By-Laws require that the winner of the 2014 Men's Class "B" World Tournament, and the winner of each 2014 Men's Class "B" National Tournament with 25 or more teams, will be automatically required to compete in a higher classification in 2015.

## **AUTOMATIC MOVE UP OF 2014 USSSA MEN'S CLASS "C" TEAMS:**

The USSSA Slow Pitch By-Laws require that the top 10 percent of the finishing teams in the 2014 Men's Class "C" World Tournament (this includes teams that are tied with teams finishing in the top 10 percent in order of their finish; all percentages are rounded up), and the winner of each 2014 Men's Class "C" National Tournament with 25 or more teams, will be automatically required to compete in a higher classification in 2015. #### **AUTOMATIC MOVE UP OF 2014 USSSA WOMEN'S CLASS "C" TEAMS:**

The USSSA Slow Pitch By-Laws require that the winner of the 2014 Women's Class "C" National or World Tournaments with 25 or more teams will automatically be required to compete in the next highest classification in 2015. The team affected by these by-laws is as follows:

The USSSA Slow Pitch By-Laws require that the top 10 percent of the finishing teams in any 2014 Mixed Class "D" World Tournament with 25 or more teams (this includes teams that are tied with teams finishing in the top 10 percent in order of their finish; all percentages are rounded up) will automatically be required to compete in a higher classification in 2015.

#### **RECLASSIFICATION OF 2014 USSSA MIXED CLASS "E" TEAMS:**

The USSSA Slow Pitch By-Laws require that the top 10 percent of the finishing teams in any 2014 Mixed Class "E" World Tournament with 25 or more teams (this includes teams that are tied with teams finishing in the top 10 percent in order of their finish; all

percentages are rounded up) will automatically be required to compete in a higher classification in 2015. The teams affected by these by-laws are as follows:

**AUTOMATIC MOVE UP OF 2014 USSSA CHURCH TEAMS:**

**RECLASSIFICATION OF 2014 USSSA TEAMS BY THE NATIONAL CLASSIFICATION COMMITTEE:**
