



2007 USSSA MEN'S CLASS E WEST WORLD TOURNAMENT

Congratulations on an outstanding season and welcome to the 2007 USSSA Men's Class E West World Tournament. The Tournament will be played at the stunning Aurora Sports Park in Aurora, Colorado, September 20-23, 2007.

Entry Procedure- Teams

As each State and Division has varying qualifying requirements for attendance at the Mens E Class World Tournament, all entries must be made through your respective State Director. No entries will be accepted directly from a team for this event. To contact your State Director to find out what the qualification requirements are for your State and Division, please visit www.usssa.com and click on 'find a director'. You must meet all requirements as laid out by your Director and Division and have all completed paperwork along with your **\$300.00** entry fee to your State Director no later than Monday September 10th, 2007.

Entry Procedure- State Directors

All entry forms (and entry fees where applicable) must be received at USSSA Headquarters by Wednesday, September 12th. Send to: USSSA National Office, Attn. Marsha Brewer, 611 Line Drive, Kissimmee, Fl 34744. State Directors must also confirm the entries of all teams from their respective states into this World Tournament through the USSSA website with an electronic 'Letter of Transmittal'. State Directors must also be sure that each team's frozen and approved roster is entered online at usssa.com. **THIS IS MANDATORY**

Tournament Entry Confirmation

Teams may confirm they have been entered into the tournament by checking the USSSA website at usssa.com. If your team is not on the website by Monday, September 17th at 3pm EST call your State Director immediately.

Rosters

Each teams qualified frozen and State Director approved roster must be posted at www.usssa.com. Changes can only be made in accordance with USSSA eligibility rules in Article III, Section 9 of the Official USSSA By-Laws. Contact your State Director for assistance with roster changes. **DO NOT CALL THE TOURNAMENT DIRECTOR REGARDING ROSTER CHANGES.**

All players participating in adult USSSA tournament play shall have photo ID available. Failure to do so will result in Rule 4, Section 11, A5 in the USSSA Rule Book to be applied. The offending team loses the game, is ejected from the the tournament, placed last in the standings and forfeits all awards, sponsors travel money and tournament berths that would have been awarded at the event.

Tournament Headquarters

The tournament will be held at the 220 acre Aurora Sports Park at 18601 E Sports Park Drive, Aurora, Co 80011 starting Thursday September 20th at 8am. The complex features 12 fields, eight lighted, all with 310-330 foot fences. No alcohol is permitted in the complex.

A mandatory managers meeting will be held at 7pm on Wednesday September 19th at 7pm at our host hotel, the Radisson Denver Southeast at 3200 South Parker Rd, Aurora, Co, 80014. The official schedule will be passed out at that time and all teams are required to have at least one team member- no more than two- in attendance.

Bracket schedules will not be mailed out in advance. All teams may check at www.usssa.com or www.rmusssa.com after 5pm MST on Tuesday September 18th to find out when they are scheduled to play. All teams must be available to play at 8am, Thursday, September 20th. **NO EXCEPTIONS.**

Hotel Bonus Award

The winning entrant will receive \$1000.00 additional travel award if the entire team is staying with an event sponsor hotel for the duration of the tournament. All teams are required to provide a Travel Information Data Sheet prior to arrival for the event for lodging verification. Teams choosing not to stay with a sponsor hotel will not be eligible for the Hotel Bonus.

Balls

RMUSSSA will provide Diamond Distance balls in optic yellow for the event.

Uniform Requirements

All teams are required to wear similar uniforms. This includes same color and style jerseys, with or without team sponsor's name. Long pants or shorts and leggings, when worn, SHOULD be similar on all team members. Caps and visors are optional. Non-duplicating numbers, at least three inches tall and clearly visible are required at all World Tournaments in 2007.

Admission

Admission will be charged at \$5.00 per person per day or \$10.00 for a tournament pass. Children under 12 are free of charge. Only rostered team members and managers will be given player passes. Player passes will be distributed at the managers meeting.
