Congratulations on an outstanding season and welcome to the 2009 USSSA Fast Pitch 14 & Under World Series Tournament. The World Series Tournament will be held in Kissimmee, Florida. Games will be played at the Disney's Wide World of Sports Complex, Osceola Softball Complex and Fortune Road Softball Complex, July 25 – August 1, 2009.

The USSSA Fast Pitch program will use a 5-game guarantee format in its World Series Tournament. Teams will be seeded into pools based on current USSSA ranking points and play a round robin. All teams will be seeded into a double elimination championship bracket following pool play. Seeding will be based on pool finish. The exact format of the tournament, e.g., number of games, number of teams in each pool, etc., will be set by the tournament director following USSSA Fast Pitch guidelines as approved by the USSSA Fast Pitch National Committee.

The World Series tournament entry form contained in this packet and a **\$450 check (made payable to USSSA) must be mailed to and received by your state director no later than JULY 10, 2009.** For a listing of state directors and their contact information, go to [www.ussa.com](http://www.ussa.com) and click on Fast Pitch State Directors. Teams must go through their state director and may not directly enter a World Series Tournament.

All team rosters must be on the USSSA website and must be the one that was submitted to your state/area director when your team qualified for this tournament. Your state director must sign the roster we receive. Failure to comply with this rule will result in your team's removal from the tournament.

**All players participating in USSSA Fast Pitch youth tournament play shall have proof of age in possession of their team manager at all times. Proof of age must be verified by a government issued document that identifies the player by name, gender and birth date. Failure to produce a copy of such document upon demand by and deemed non-fraudulent by a tournament official will result in the offending team losing the game, being eliminated from the tournament, being placed last in the standings and forfeiting all awards, sponsors travel money and tournament berths that would have been awarded at the tournament.**

**NOTES:**

- 1) Any player who reached their 15<sup>th</sup> birthday on or before December 31, 2008 shall not be eligible to play in the 14 & Under "B" World Series Tournament.
- 2) Any player can play in a higher age classification but cannot play in a lower age group.
- 3) All players must wear identical uniforms. This includes jerseys, long pants or shorts and leggings. Whether long pants or shorts are worn all team members must be uniformed alike. Caps are optional, however when worn, they must all be alike and worn with the bill forward. Non-duplicating numbers will be required and must be a minimum of three inches in size and clearly visible. Protests on uniforms will not be allowed. It shall be the World Series Tournament Directors responsibility regarding uniform legality. Violation of the uniform rules will result in the violator being allowed to conform or be removed from the game.
- 4) Players in the game are prohibited from wearing jewelry. Medical alert bracelets or necklaces are not considered jewelry. If worn they must be taped to the body, so as to remain visible. If jewelry is not removed, that player will not be able to play until the jewelry is removed.
- 5) NOCSAE approved batting helmets with extended earflaps which cover both ears, and temples and NOCSAE approved face guards are mandatory for batters, on deck batters, base runners, non-adult bat and ball shaggers and any offensive player in live territory, even if the ball is dead.
- 6) The catcher shall wear a NOCSAE approved head protector, an approved mask with throat protector, body chest protector and shin guards. All protective equipment must conform to industry standards.
- 7) Any non-adult warming up a pitcher within the confines of the playing field must wear an approved protective mask with throat protector.
- 8) When an umpire observes anyone required to wear a batting helmet deliberately removing the batting helmet while the ball is alive, and that person is in live ball territory, the umpire shall issue a warning to the coach of the involved person's team. All subsequent violations of the rule shall result in an out.
- 9) The official USSSA Fast Pitch Softball Rule Book and National By-Laws shall govern all playing rules or policies not specifically covered above. Note that the Rule Book printed online at [www.ussa.com](http://www.ussa.com) will always supersede the latest printed version if a discrepancy exists.

Bracket schedules will not be mailed out in advance. The pool play and double elimination brackets will be given to coaches during the team check-in. Player and coach's tournament passes will also be distributed at the team check-in.

**Note:** All times are subject to change. Please verify itinerary during team check-in. Once the tournament begins, managers must check the main bracket board for any changes in game times, field assignments or other items related to tournament play or functions.

#### **Gift Exchange**

There will be a non-mandatory team gift exchange during opening ceremonies. Teams wishing to participate should bring something that is representative of their home area, the value of which is not important. It is recommended that teams bring a minimum of 16 gifts to exchange.

#### **Admission**

**Spectator Admission is as follows: \$ 12.75 per adult per day or \$ 51.00 per adult for a tournament pass. For children ages 3-9 it is \$ 10.00 per day or \$ 40.00 for a tournament pass. Children under 3 are free. This charge includes everyone except players and team coaches. A maximum of 3 coach passes and 20 player passes will be issued. Player passes will only be issued to those listed on the submitted roster, and only players in uniform will be allowed to enter on a player pass.**

#### **Softball & Bats**

The tournament ball will be the **Worth Red Dot**, yellow leather cover, blue stitched, .47 cor. All bats must be on the most recent USSSA approved list (listed on [www.ussa.com](http://www.ussa.com)), must have a manufacturer's stamp of 1.20 BPF and must bear the USSSA logo.

## RULES OF CONDUCT

It is the purpose of the United States Specialty Sports Association to conduct the best possible Tournaments from all aspects. To achieve this objective the USSSA must have the cooperation of each player, manager, coach and sponsor.

We are guests in the city that the tournament is conducting and nothing should occur that would reflect adversely on your team, players, our host city, or the United States Specialty Sports Association. Therefore, it is required that all teams in the tournament comply with the following rules:



1. Team managers must have full control of their respective players at all times. This means "on" and "off" the field, course, or court.
2. In case of disputed play or decision, team managers or captains may consult with the game officials. The other players and coaches or sponsors are to be kept out of the discussion.
3. Managers, coaches and players are not to fraternize with spectators while participating in an event. At no time will any participants be allowed to smoke while participating in any USSSA event.
4. At no time will participants be allowed to drink or have in their possession any alcoholic beverage while participating in any USSSA event.
5. Managers are to report any unsportsmanlike or derogatory acts by players or spectators to the tournament director. The purpose here is to prevent any serious situation developing that would be harmful to the tournament.
6. Managers, coaches, players, sponsors and teams are liable for suspension by not adhering to the tournament rules in effect. This could mean suspension for a game, games, tournament or a longer duration depending on the act of violation.
7. A player, coach, manager or sponsor may be suspended for fighting, abusive tactics or unbecoming acts that are detrimental and not in the best interest of the United States Specialty Sports Association and tournament play.
8. Be careful of your conduct. Be sure that no action occurs that could reflect adversely on your sponsor, team or division. Remember that the wrong actions of even one player can reflect upon your entire team and the various sporting programs.
9. Any report by the hotel or motel management, where any team competing in USSSA championship play is staying, of destruction of property or abuse of hotel or motel property will be dealt with very sternly. Team managers and sponsors will not be warned other than through the notice. Failure to pay hotel or motel bills can result in team disbarment from future USSSA play.
10. Any team submitting bad checks to the USSSA will be subject to disbarment.
