

# **TEAMS AUTOMATICALLY RECLASSIFIED BY THE USSSA BY-LAWS FOR 2010**

***PLEASE NOTE:** Teams required to compete at a higher classification in 2010 by the USSSA By-Laws that may be inadvertently omitted from the list below are not exempt from being reclassified.*

## **AUTOMATIC MOVE UP OF 2009 USSSA MEN'S CLASS "B" TEAMS:**

The USSSA Slow Pitch By-Laws require that the winner of the 2009 Men's Class "B" World Tournament, and the winner of each 2009 Men's Class "B" National Tournament with 25 or more teams, will be automatically required to compete in a higher classification in 2010. **AUTOMATIC MOVE UP OF 2009 USSSA WOMEN'S CLASS "C" TEAMS:**

The USSSA Slow Pitch By-Laws require that the winner of the 2009 Women's Class "C" National or World Tournaments with 25 or more teams will automatically be required to compete as a Class "B" team in 2009. The team affected by this by-law is as follows:
