



## **USSSA Men's Class "D" World Tournaments**

Congratulations on an outstanding season and welcome to the 2010 USSSA Men's Class "D" World Tournament. The tournament will be played in Kissimmee, Florida hosted by ESPN Wide World of Sports Complex and the Osceola County Softball Complex, September 23-26, 2010.

The USSSA Softball program will use the "double elimination" format in its World Tournaments.

The tournament entry fee is \$315. All entry fees must be paid online at [www.USSSA.com](http://www.USSSA.com).

Please follow these procedures to complete your entry into the tournament.

### **ENTRY PROCEDURE – Teams With Paid Berths**

All teams must be marked "qualified" on the [www.USSSA.com](http://www.USSSA.com) site by their state director. Additionally, teams with Paid Berths must complete and return their Berth Commitment form to the tournament director who will then forward to the National Office. Team entry form must be received by your USSSA State Director by Monday, September 6, 2010. For a listing of USSSA State Directors, visit the USSSA website at [www.USSSA.com](http://www.USSSA.com). State Directors must email or fax all required forms to USSSA National Office, Attn: Wendi Brockwell by Wednesday, September 8, 2010. State Directors must confirm the entries of all teams from their respective states into this World Tournament through the online berth approval process. State Directors must also insure that each team's frozen and approved roster is entered online at USSSA.com. THIS IS MANDATORY!

### **ENTRY PROCEDURE – Teams with Unpaid Berths**

All teams must be marked "qualified" on the [www.USSSA.com](http://www.USSSA.com) site by their state director. Once a team has been marked "qualified", the team can enter and pay for the event online at [www.USSSA.com](http://www.USSSA.com). All entry fees must be paid online through the [www.USSSA.com](http://www.USSSA.com) website – NO EXCEPTIONS. Additionally, teams must complete their entry form and travel information sheet and submit to USSSA Headquarters by Monday, September 6, 2010. State Directors must also confirm the entries of all teams from their respective states into this World Tournament through the online berth approval process. State Directors must also insure that each team's frozen and approved roster is entered online at [www.USSSA.com](http://www.USSSA.com). THIS IS MANDATORY!

### **TOURNAMENT ENTRY CONFIRMATION**

### **ROSTERS & WAIVER FORMS**

Each team's qualified frozen and approved roster must be posted on the USSSA website at [www.USSSA.com](http://www.USSSA.com). Changes may only be made in accordance with USSSA eligibility rules in Article III, Section 9 of the Official USSSA By-Laws. Contact your State Director for assistance. **PLEASE DO NOT CALL THE TOURNAMENT DIRECTOR OR USSSA NATIONAL HEADQUARTERS REGARDING ROSTER CHANGES!**

*All players participating in USSSA tournament shall have photo ID available. Failure to do so will result in Rule 4, Section 11, A5 in the USSSA Rule Book to be applied. The offending team loses the game, is ejected from the tournament, placed last in the standings and forfeits all awards, sponsors travel money and tournament berths that would have been awarded at the tournament.*

**ALL PLAYERS and COACHES MUST SIGN** the ESPN Wide World of Sports Waiver Form. You can find the waiver form at [www.USSSA.com](http://www.USSSA.com), on the Slow Pitch home page. Having the waivers filled out in advance will streamline the check-in process.

**Tournament Headquarters:** ESPN Wide World of Sports Complex Stadium (home of the Atlanta Braves spring training site). All information concerning this World Tournament will be posted at [www.USSSA.com](http://www.USSSA.com). Please check in upon arrival so that we know you are here, where you are staying and make sure all your papers are in order. Team check-in will be Wednesday, September 22, 2010 from 4:00 pm to 8:00 pm and Thursday, September 23, 2010 from 7:00 am to 2:00 pm at ESPN Wide World of Sports.

Bracket schedules will not be mailed out in advance. Beginning Tuesday, September 21, 2010, you can go to [www.USSSA.com](http://www.USSSA.com) to find out when your team is unofficially scheduled to begin play. **All teams must be available to play Thursday morning at 8:00 am September 23, 2010. NO EXCEPTIONS!**

There will be a **Manager's Meeting at 6:00 pm, Wednesday, September 22, 2010** at the ESPN Wide World of Sports Complex. All teams are required to have a representative in attendance. The official schedule for teams playing will be distributed at that time.

#### **Balls:**

Your World Tournament host will provide USSSA approved softballs for the entire tournament.

#### **Uniform Requirements:**

In accordance with the USSSA Slow Pitch By-Laws, teams must wear similar uniforms. This includes the same color and style jerseys, with or without the team sponsor's name. Long pants and/or shorts may be worn. Leggings, when worn, must be similar on all team members. Caps are optional; however, when worn, they must be similar. Non-duplicating numbers will be required. The numbers must be a minimum of 3 inches in size and clearly visible. See Article V, Sec. 8c.

Uniform violations are not grounds for protest.

#### **Travel Money:**

**VERY IMPORTANT!** If your team is eligible to receive Travel Money from your participation in a National, NIT or other sanctioned event, your team must book the ENTIRE team for the ENTIRE length of the event at one of the Host Hotels on the Hotel Information Sheet (this can also be found at [www.USSSA.com](http://www.USSSA.com) under the Travel Center). All reservations must be made through the hotel sales manager listed on the travel center, NOT THROUGH THE INTERNET. All travel money will be sent to the Host Hotel and credited to your rooms provided you meet all criteria as set forth by the USSSA National Office.
