Congratulations to your team on an outstanding season and welcome to the **2010 USSSA Midwest Division Men's C National Tournament**. Your USSSA State Director must enter your team into this double-elimination format tournament.

To qualify for a berth, all teams must be properly registered with the USSSA for this current year and must abide by all local, divisional, and USSSA tournament qualification rules as administered by their respective USSSA State Directors. All teams must have played in their respective state tournament.

Tournament Facilities: The tournament will be held at Virginia Weaver Softball Complex, 631 Somerset Dr., Cedar Hill, Tx, 75104.

Entry Information

The cost of the tournament will be **\$325.00** per team. Payments must be made with either a Cashier's Check or Money Order, made payable to USSSA. All entries must be paid to your state director who will then notify the tournament director of your entry into the tournament.

Deadline to enter: Friday, August 20, 2010...5p.m.

Roster MUST be online at ussa.com and approved by your State Director.

Hotel Information: See attached for a list of host hotels and special rates.

Tournament Format: The format for this tournament is double elimination. Official tournament games will begin on Saturday. Teams need to be ready to start @ 7 a.m. on Saturday if needed.

Tournament director reserves the right to change format of tournament if it is determined that it would not be possible to continue the double elimination format due to weather or acts of God. An alternative plan would be put into place in order to complete the tournament in a timely manner.

Starting Times: TEAM MANAGERS ONLY may call for their starting times at 2 p.m., **Thursday, August 26, 2010**. Please call Cedar Hill Parks & Recreation at (972) 291-5130. Bracket will also be available on the USSSA website at that time.

Balls: Tournament host will provide balls for this tournament.

Uniforms: Protests on uniforms will not be allowed, but it will be the Tournament Director's responsibility regarding uniform legality.

Protests Procedure: The protest fee is \$100 in cash. In case of an eligibility protest, the protest fee will be \$100 in cash per player. The fee shall be returned if the protest is upheld.

Player ID: All players must produce a valid ID to tournament director if there is a question of identity. Failure to do so will result in Rule 4, Section 11, A5 in the USSSA Rulebook to be applied. The offending team loses the game, is ejected from the tournament, placed last in the standings and forfeits all awards, sponsors travel money and tournament berths that would have been awarded at the tournament.

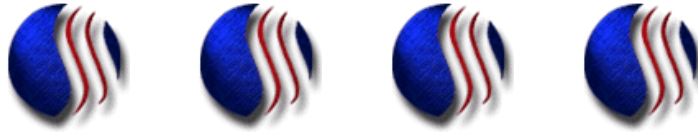
EXCEPTIONS: If the loss occurred by the offending team was it's first loss of the tournament and if the player(s) in question can subsequently furnish a valid photo ID prior to the next game, the offending team may remain in the tournament. Player protests will be charged a \$100 per player protest.

Berths: One (1) berth to the respective World Tournament will be awarded from each Men's C National tournament. If the highest finishing team(s) already has a paid World Berth, the berth can pass down to the next highest finishing previously unqualified team. Teams winning a Men's C National Tournament will also receive \$600 travel. The travel is available to the winner only and does not pass down. Travel money will be sent to the official host hotel and credited to the team's rooms. If the team chooses to not stay at the host hotel, the travel money will be forfeited.

Coaches Meeting: MANDATORY coaches meeting will be held at 7 p.m. Friday night (meeting place to be announced). Official brackets will be handed out in the tournament packets at this time.

Conditions: Upon entry into this tournament, all players, coaches, fans, team representatives, and spectators accept full responsibility upon themselves for any injuries which may result from competing, observing, or participating in activities relating to the tournament. Tournament Officials, Sponsors, USSSA Officials, Umpires, and Cedar Hill Parks & Recreation will not be liable for any accidents or injuries which may occur. Entry into the tournament constitutes an Agreement to the above stated conditions.

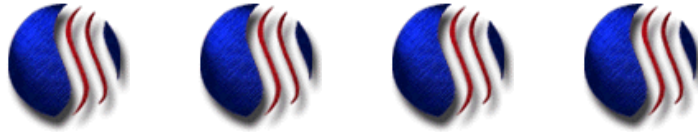
