Entry Fee & Entry Form: All teams must abide by the National tournament qualification rules as administered by their respective State Directors. State Directors will forward all rosters and payments to tournament headquarters.

2. Completed entry form and team information form.

Tournament Play: Tournament play will begin Saturday, August 28, 2010 at 9:00am.

Conditions: The tournament will be scheduled using a double elimination format. The tournament director reserves the right to change the format (i.e., locations of fields, game times, and dropping of losers bracket due to inclement weather or conditions.) The conversion to single elimination or other format changes would only take place at that point in which it becomes mathematically impossible to complete the tournament on Sunday, August 29, on a double elimination basis.

Upon entry into this tournament all players, and spectators, accept full responsibility for themselves for any injuries which may occur. Entry into this tournament constitutes an agreement to the above conditions.

Bracket Scheduling (Game Times): All brackets will be on-line and emailed out. Teams may call Maryland USSSA at 410-641-3404 between the hours of 7:00-10:00pm, on Wednesday, August 25, 2010 for your teams first game time.

Scores: Each team is responsible for game scores.

Uniforms: 2010 USSSA Rule Book.

Balls: USSSA approved balls will be sponsored.

Official Bat Inspection: Umpires will inspect bats before every game. Bats not passing inspection will be held by the Tournament Committee until the team has been eliminated from the tournament.

Awards: Trophies and awards will be presented as follows:

- B. Championship team trophy
- C. Second place team trophy
- D. Third place team trophy
- E. Fourth place team trophy
- F. Individual awards to each player on the Championship and runner up teams
- G. Most valuable player award
- H. Outstanding offensive player award
- I. Outstanding defensive player award
- J. Most home runs award
- K. All tournament team individual awards
